NOTIFICATION

In exercise of powers conferred on the Governing Body in clause 12 (n) of the Rules and Regulations of the PKMC Society notified in G.O Ms.No.30 dated 31st May, 2005, read with the G.O.Ms.No.47 dated 12.08.2005 of Health Secretariat, Puducherry and in supersession of the Recruitment Rules, 2010 (approved as per 11th Governing Body meeting dated 28.01.2010), in so far as they relate to the post of General Duty Medical Officer, except as respect things done or omitted to be done before such supersession, the Governing Body (PKMCS) hereby makes the following rules regulating the method of recruitment to the Group 'A' Non Gazetted – Non Ministerial post of General Duty Medical Officer in IGMC&RI, Puducherry, namely:-

1. Short title and Commencement:

- a) These rules may be called Indira Gandhi Medical College & Research Institute Recruitment Rules, 2023.
- b) They shall come into force on the date of their notification.
- **2. Application:** These rules shall apply to the posts as specified in Column 1 of the schedule hereto annexed.

3. Number of posts, its classification and Level in the Pay Matrix:

The number of posts, its classification and the Level in the Pay Matrix pay attached thereto, shall be specified in column (2) to (4) of the Schedule annexed to these rules.

4. **Method of recruitment, age limit and other qualifications**, etc. – The method of recruitment, age limit, qualification and other matters relating to the said post shall be as specified in columns (5) to (12) of the said schedule.

5. **Disqualification:** No person-

- a) who has entered into or contracted a marriage with a person having a spouse living; or
- b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post;

Provided that the Governing Body of the Perunthalaivar Kamaraj Medical College Society may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- Power to relax: Where the Governing Body of the Perunthalaivar Kamaraj Medical College Society is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing with the approval of Hon'ble Lieutenant Governor, relax any of the provisions of these rules with respect to any class or category of persons. The Departmental Promotion Committee has powers to relax the requirements in respect of candidates who are otherwise meritorious.
- Saving: Nothing in these rules shall affect the reservations, relaxations in upper age limit and other concessions required to be provided for the scheduled castes, the scheduled tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
