



**23.6 Establishing College of Nursing at IGMC & RI, Puducherry.**

The Director, IGMC&RI briefed about the College of Nursing established at IGMC&RI, Puducherry with the approval of Competent Authority. The Governing Body noted the same.

**23.7 Approval / Ratification for payment of fees made to Pondicherry University for commencing new B.Sc., Nursing Course**

Ratified.

**23.8 Starting of College of Allied Health Sciences at IGMC & RI**

The Director cum Member secretary explained about the 8 B.Sc. Allied Health Science courses proposed to be started at IGMC&RI and out of 8 courses, the approval of the Government has been obtained for 3 courses and starting of such courses will improve the patient care of the Hospital

After detailed discussion, the Governing body has approved the starting of 8 Allied courses in this institute.

**23.9 Withdrawal of Agenda Point 22.16 approved in 22<sup>nd</sup> GB meeting (Proposal for implementation of service bond after completion of degree by Post-Graduate Students).**

The Director cum member secretary explained about the non requirement of service bond after completion of degree by PG students. The Director, DHFWS, DD (PH) and MS, IGGGH&PGI mentioned that the NMC task force is an advisory, but not mandated and suggested to execute atleast one year service bond with students who have completed the PG course on Govt. Quota similar to neighbouring states.

The Director, IGMC&RI stated that the execution of one year service bond may also be extended to the Private medical College students on Government Quota and insisting of service bond only to this Institute will impact/influence students to go to Private Colleges.

After detailed discussion, the GB decided to defer the proposal and to place it before GB after the policy decision taken by the Government in this regard.

**23.10 Withdrawal of Agenda Point 22.19 approved in 22<sup>nd</sup> GB meeting (Approval for merging the post of Casualty Medical Officer with General Duty Medical Officer (GDMO)).**

The Director, IGM&RI stated that in the light of observations made by the DP&AR regarding the merger of CMO and GDMO posts, it has been proposed to withdraw the decision taken in 22<sup>nd</sup> GB meeting. The Chairman questioned about the differences in pay level and eligibility conditions between the CMO and GDMO posts. The same has been explained in detail to the Hon'ble Chief Minister cum Chairman.

After detailed discussion the GB approved to withdraw Agenda Point No. 22.19 "***Approval for merging the post of Casualty Medical Officer with General Duty Medical Officer (GDMO)***" decision taken in the 22<sup>nd</sup> GB meeting considering that the eligibility conditions is different between the two posts.

**23.11 Summer and Winter Vacation for Faculty members – Ratification.**

The Governing Body ratified the summer and winter vacation availed by the faculty member of this institute. The GB also approved the EL in lieu of unavailed portion of vacation and EL in lieu of HPL to be credited to the faculty availing vacation every calendar year.

**23.12 Approval for Starting of New Post Graduate Courses.**



**23.16 Approval for Creation of Intramural Research fund for promotion of research in the Institution.**

Approved. Nominated Member from Pondicherry University suggested to raise the fund from Rs. 25 lakh to Rs. 1 Crore. However, the DD (PH) and the MS, IGGGH&PGI observed that the funding may be increased gradually in a phased manner starting from Rs. 25 lakhs initially and allocation to be made every year to reach the maximum limit of Rs. 1 Crore so as to reduce the financial burden. The Board agreed the same.

Considering the necessity and development in Medical Research, the Board approved the proposal.


The Board gave its approval and the Vice-Chairman, PKMCS instructed to submit the file in detail for consideration as per INC norms.



Noted. The Governing Body observed that these posts are essential for running the hospital smoothly and insisted to fill all those posts on priority basis as per extant recruitment rules. The Chairman, PKMCS suggested that the methodology being followed in Indira Gandhi Govt. General Hospital, Puducherry for recruitment of Nursing Officer may be adopted for recruitment of Nursing Officers post in IGMCR&RI also.

**23.25 Ratification on Re-engagement and Regularization of 7 Multipurpose Workers who were posted at Rajiv Gandhi Ayurveda Medical College, Mahe on consolidated remuneration basis as per Hon'ble High Court of Madras in Contempt Petition No.7 of 2024 in Contempt Petition No.1001 of 2020.**

The Director cum Member secretary explained that typographical errors in the Recruitment Rules (RR) for the Nursing Cadre posts resulted from discrepancies in the sanctioned posts.

As the typographical error was genuine, the Governing Body approved to make necessary correction in the Recruitment Rules of the said posts as carried out previously in Nursing Officer post with the approval of GB in its 22<sup>nd</sup> meeting.

**23.27 Creation of one post of Legal Assistant exclusively for handling court cases of Institutions functioning under PKMCS.**

The Director cum Member secretary briefed on the challenges faced by IGM&RI and RGAM&H, Mahe in handling court cases and emphasised the need for creation of a Legal Assistant post to alleviate these difficulties. The MS, IGGH&PGI asked about the eligibility conditions and method of recruitment. In turn, the Director cum member secretary informed that the eligibility conditions and method of recruitment shall be adopted on par with Government.






**23.36 Consolidation and enhancement of various imprests operated by the Engineering Division**


**23.41 Outsourcing of various Electrical Services.**


The Director cum Member secretary briefed about the directions of Hon'ble Court of Judicature at Madras in its order dated 02.11.2023 and the action taken to comply with.

**8. Engaging the services of M/s. Hindustan Steel Construction Limited (HSCL) as Project Management Consultant (PMC) for various developmental works for RGAMC&H, Mahe.**

M/s. HSCL in their letter dated 26.06.2024 has stated that they have made an investment in setting up of office, preparation of DPR and deployment of resources and insisted to execute Memorandum of Understanding with them.




During the discussion on Agenda Points, the Hon'ble Chief Minister cum Chairman and Secretary to Govt (Health) cum Vice Chairman has informed/directed the following instruction/guidelines for smooth and development of the institution

- ❖ 1. The Hon'ble Chief Minister has informed that the medical college has started under society for the purpose of quick decision and timely action to implement the Academic activities, recruitment activities, construction etc within the time without any delay for the welfare of the students and patients. Hon'ble Chief Minister has directed to expedite the all the above said activities in time.
- ❖ 2. The Hon'ble Chief Minister cum Chairman expressed that the progress of OT work is slow and advised to expedite the work so that it would be completed as soon as possible.

The Director and Superintending Engineer, IGM&RI explained the reasons for delay in progress of work i.e. the error made by the consultant Architect in setting up of HVAC systems for state of art OT and assured that necessary steps would be taken to rectify the errors with the help of experts to complete the work within the scheduled time and the fund allocated will be utilized fully.


