MEMORANDUM

Sub: IGMC & RI – Academic – Offer of Contract
Appointment to the post of Junior Residents – Reg.

Dr.<Name> is hereby offered appointment to the post of **Junior Residents** in Indira Gandhi Medical College and Research Institute, Puducherry on contract basis for a period of one year on consolidated emolument of **Rs.50,000/- p.m.** on the following conditions.

1. His/ Her service is liable for termination on one month's notice from either side.
2. The appointing authority however reserves the right to terminate his / her service forthwith without assigning any reason i.e., before the expiration of the stipulated period of notice unexpired portion thereof. It is also informed that application for no objection certificate towards seeking jobs elsewhere or otherwise will not be entertained except in special circumstances.
3. Further in case of misconduct, the undersigned reserves the right to terminate the contract without any notice.
4. With regards to leave he/she is eligible for weekly off / compensatory off, if required to work on Government holidays as declared by the Government in addition to the post duty off (stay in duty). He/ She is also eligible for Casual Leave not exceeding 8 days during the current year along with 15 days of Leave on Medical grounds.
5. If he / she is already employed, the relieving order from the employer should be submitted.
6. Wherever applicable, he / she should produce the certificate in the prescribed form issued by competent authority in case of SC / ST / OBC obtained within a period of three months before taking the appointment.
7. In accordance with the relevant rules in regard to the recruitment to services under this administration,

.....2/-

- (a) No person who has more than one wife living or who having a spouse living, marries in any case in which such marriage is void by reason of its taking place during the life-time of such spouse, shall be eligible for appointment to service; and
- (b) No woman whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for appointment to service;

Provided that the Central Government may, if satisfied that there are special grounds for so ordering exempt any person from the operation of this rule.

8. This offer of appointment is further subject to –

Production of medical certificate of fitness in the prescribed form from the MS / RMO / PRO of this institution.

9. If any declaration submitted or information furnished by him / her is proved to be false or if he / she has willfully suppressed any material information he/she will be liable for removal from service and other disciplinary action will be taken if required.

10. If you accept the offer on the above terms and conditions, you are requested to report yourself for duty immediately but in any case not later than **to join duty within 15 days from the date of issue of offer of appointment** with the following documents.

- (a) Original certificate of educational qualification and Medical Council Registration certificate for UG / PG along with a set of attested copies.
- (b) Certificate of Age, Aadhaar Card, PAN card, etc.
- (c) Relieving order from the present employer, if any.
- (d) Community certificate in case of SC / ST / OBC candidates in the prescribed form wherever applicable.

11. As the consolidated emoluments mentioned above includes NPA, he / she is not allowed to do private practice.
